

Announcement of Nakhon Sawan Rajabhat University

On

Announcement of intention to Not Accept All Kinds of Gifts and Rewards from the Performing Duties (No Gift Policy), Fiscal Year 2025 (B.E.2568)

In accordance with the Cabinet resolution on December 8, 2020, approved the national reform plan for the prevention and suppression of corruption and malfeasance (revised edition) by determined key reform activities within Activity 4, focusing on Developing the Thai Government System to be Transparent and Non-Beneficial, Goal 1.Point 1.1: All state officials are required to declare themselves as organization where officials do not accept gifts and rewards of all kinds in the performance of duties (No Gift Policy).” This directive aims to drive the reform activities outlined in the national reform plan. It serves to foster transparency within the organization, cultivate a positive attitude, instill values in the performing duties, and contribute to all government officers within state officials to abstain from accepting all kinds of gifts and rewards in the performing duties (No Gift Policy). The goal is to transform the organization into one that is transparent and free from all forms of corruption.

Therefore, Nakhon Sawan Rajabhat University hereby declares its intention to have all executives and personnel within Nakhon Sawan Rajabhat University refrain from giving or receiving gifts to outsiders who come into contact during all festivals or occasions and refuse to accept gifts to benefits of all kinds before, during or after the performance of duties that will result in corruption and misconduct.”

By virtue of Article 31(1) of Nakhon Sawan Rajabhat University Act, 2547 B.E. and together with memorandum of agreement About No Gift Policy culture creating. According to the announcement of the intention of the No Gift Policy. Refusal to accept gifts and presents of all kinds in the performance of duties of Fiscal year 2025. In the meeting of the University Administrative Committee meeting at 1/2568 B.E. on January 14, 2568 B.E., Nakhon Sawan Rajabhat University hereby announces as follows:

Section 1: This announcement shall be known as “Announcement of Nakhon Sawan Rajabhat University on Announcement of Intention not to accept All Kinds of Gifts and Rewards from the Performing Duties (No Gift Policy) for Fiscal Year 2567 B.E.”

Section 2: This announcement is effective from the date of issuance onward.

Section 3: Any other announcement or orders that conflict or contradict with this announcement shall be replaced by this announcement.

Section 4: Nakhon Sawan Rajabhat University has an intention to refrain from accepting all kinds of gifts and rewards from external parties who interact with Nakhon Sawan Rajabhat University in their performing duties.

Section 5: Nakhon Sawan Rajabhat University has an intention to refrain from providing all kinds gifts and rewards to external parties who interact with Nakhon Sawan Rajabhat University.

Section 6: Nakhon Sawan Rajabhat University is committed to not seeking to receive gift,rewards, or benefits that are contrary to the law.

Section 7: Nakhon Sawan Rajabhat University is committed to expressing congratulations,good intentions.welcome, or condolences on various occasions according to customary traditions. It utilizes methods such as signing on greeting cards,condolence books,or expressing sentiments through online social media instead of presenting physical items.

Section 8: Nakhon Sawan Rajabhat University hereby announces that all personnel within the university and external individuals should be informed and adhere strictly to the No Gifts Policy.

Section 9: The President is designated as the custodian of this policy and is empowered to issue directives for its implementation. Additionally,the President acts as an arbitrator in cases of disputes arising from the application of this policy.”
